PERSONAL STATEMENT

Thank you for the opportunity to continue to serve on the board of trustees. I have been a resident of the Ohio City neighborhood since I moved to Cleveland in 2007. I have lived in the neighborhood as both a renter and an owner. I have seen the unbelievable renaissance of this already unbelievable neighborhood and would like to help in its continued, responsible development.

I am currently an attorney at the national labor and employment law firm Littler Mendelson, P.C. I also teach several courses as an adjunct professor at Cleveland-Marshall College of Law. Prior to joining the law firm, I was a law clerk to United States District Judges Ann Aldrich and Kathleen M. O'Malley for three years. My educational experience includes a BA in Philosophy, a Masters in Public Administration, and a Juris Doctorate. Of particular interest to me are urban policy, history, and preservation. I have published several law review articles on urban sprawl, urban development, issues facing urban families, and I am the co-author of the 7th and 8th Editions of Environmental Law (a text for undergraduate courses).

My partner, Jason Bristol, and I recently built a new home at 3300 Clinton Ave. – a federal style home befitting of the historic neighborhood. In 2015, our new home was part of the Ohio City Home Tour, and Ohio City Inc. awarded us the best new single family home award.

I am very involved in our community. For the past three years, I have served on the Board of Ohio City, Inc., and work on the Real Estate and Land Use committee. I am the Vice Chair of the Franklin/Clinton block club and the Chair of the block club's Development Committee. In this role, I worked to draft the block club's first ever by-laws as well as to draft the block club's recommendations on the City's proposed rezoning of our community. I am committed, in both roles, to historic preservation and promotion of sensible development that benefits the whole of the neighborhood.

Additionally, I serve as the Vice Chair of the St. John's Institute, a group formed to explore the community's use

of the historic church and parish hall. St. John's Institute arose from my founding of the Friends of St. John's, which was the initial version of the Institute. One of the community events that has arisen out of our efforts is the annual Station Hope, produced and led by Cleveland Public Theater. We are working on several projects which should dramatically enhance this portion of Ohio City over the next year. I am also a Board member of the Refugee Response, which assists refugees in settling in Cleveland and runs the Ohio City Farm.

Outside Ohio City, I have served as the president of the American Constitution Society for Law and Policy – a progressive minded national public policy non-profit with local chapters throughout the United States.

My interests include running, gardening, bee keeping, baking, reading and flying.
